The Reserves account balance is (\$194,685.13). Payments on the association loan of \$464,059.56 obtained in September 2016 will be completed in September 2023. Funds allocated to that line item in the budget for the remainder of 2023 and going forward will be deposited into the Reserves account.

- a) aggressive collection of delinquent assessments;
- b) animal remediation on Caspian Way and repairs to Building 7;
- c) inspection of remaining buildings regarding animal intrusions;
- d) regular contributions to the Reserve Account;
- e) various maintenance in community.

Goals and Projects in 2023 include:

- a) repairs to six buildings to prevent animal intrusions;
- b) update parking passes;
- c) collections of delinquent assessments;
- f) work on building the Reserves Fund.
